

RESOLUTION NO. 10-2022

“A RESOLUTION AMENDING SOLID WASTE COLLECTION FEES FOR FISCAL YEAR 2022”

WHEREAS, Perkins Public Works Authority entered into a contract with Davis Sanitation, Inc., on May 20, 2020, for the collection and removal of garbage, refuse, waste materials, et al; and

WHEREAS, said contract included a Fuel Surcharge to be calculated at a rate of a 15% increase for every \$1.00 per gallon over the price of \$2.75 per gallon of fuel; and

WHEREAS, the Perkins Public Works Authority has determined that this additional cost shall be assumed by its customers;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF PERKINS THAT THE FOLLOWING SCHEDULE OF FEES BE AMENDED IN THE CITY FEE SCHEDULE:

Residential Solid Waste Collection Fees:

Fees to be charged on a monthly basis

One Polycart -- \$15.34

Additional Polycarts -- \$7.31 each

Residential Orange Bag Collection Fees:

Bags will be purchased at City Hall and can be used for additional waste that will not fit in a customer's polycart.

Single Bag -- \$1.77

Five (5) Bags -- \$8.11

Roll-Off Containers:

Roll-Off Container Delivery Fee -- \$304.20

Roll-Off Container Dumping Fee -- \$31.94 per ton

Residential & Commercial Fuel Surcharge:

When applicable, the fuel surcharge rate will be calculated a month in arrears and based on the actual cost of fuel, to be divided equally by the number of customers receiving sanitation service and added to the Solid Waste Collection Fees.

The above listed rate schedule shall be effective June 14, 2022.
